Seminar

Social security within the Americas at debate: towards a 2030 hemispherewide agenda

Context

During the decade of the eighties and particularly in the nineties various reforms to social security schemes were conducted in the Americas, both in relation to pension systems and in the area of medical care services. Additionally, social assistance programs and initiatives now comprise a more relevant component in terms of providing protection to the population which remains outside the scope of contributed-scheme coverage. The aforementioned reforms and attempts to address coverage have yielded an entire spectrum of thoughts, experiences and practices. In fact, many nations are currently reforming or overhauling their social security and social protection systems.

Additionally, the impact of the last decade's international financial crisis is still being felt throughout the economies which comprise the hemisphere and beyond. Recently, leading international financial organisms such as the International Monetary Fund, World Bank and Inter-American Development Bank, have concurred on the fact that economies within the Americas are currently experiencing relatively low performance rates. Furthermore, the prognosis for the near-term horizon is fairly flat.

This scenario has caused a wide spectrum of very tangible ramifications for social security schemes throughout the hemisphere. It has completely restructured expected results and provoked the necessity to generate contingency plans to adjust to the new dynamic, even as it has also provided an opportunity to undertake structural overhauls of the systems in question; particularly pension and healthcare systems, although social protection and assistance programs have also been addressed.

Roundtables sessions

The roundtable sessions are designed to provide an opportunity to share knowledge and generate discussion on relevant topics within the field of social security within the Americas, by subject-matter experts and key actors within the field.

The specific objectives are as follows:

- Generate a forum for dialogue on the latest advances and challenges to the promotion, management and implementation of social security
- Serve as a platform to gather and expound upon regional initiatives and policies put forth by the Membership and subject-matter experts on issues relating to the management and promotion of social security, as well as other generalized aspects of this issue
- Analyze the latest developments, challenges, causal agents and the perspectives that arise, wich allows to restore work strategies and joint collaboration lines.

Roundtables sessions

Objetive

The roundtable sessions are a valuable asset to the Inter-American Conference on Social Security whereas they comprise a forum which brings together the membership and key actors within the sector, even as it provides an ideal instance for discussion, collaboration and high-level decision-making.

Through the use of a moderator, it is seldom the discussion will produce a succinct analysis of the current state of affairs within the social security sector within the Americas (especially as regards taking stock vis-à-vis the reforms undertaken in recent years), current reform trends (as well as their causes and aims), as well as challenges in terms of coverage and financial sustainability; i.e., what solutions are being put forth given the current scenario.

As a result, the sessions constitute an opportunity for the Conference to identify the principal challenges, difficulties and preoccupations the membership face as they attempt to design their respective work agendas. They are also of value as member-entities embark on short, medium and long-term collaboration initiatives designed to help the parties involved achieve their aims and objectives.

Within the framework of the social security within the Americas at debate: towards a 2030 hemisphere-wide agenda seminar, three primary issues have been identified as starting points designed to generate active debate between the participants, as well as to achieve the expected objectives and results.

Roundtable I.

Social security systems in the Americas: current state of affairs

Analysis on the current state of affairs of social security systems throughout the Americas, as well as changes observed within recent years, designed to provide an up-to-date snapshot to member-states and other key actors of what actions are being undertaken throughout the hemisphere.

Another element under consideration will be the impact of the international financial crisis and the economic outlooks of social security systems: what has occurred, how the crisis impacted social security schemes, how had they reacted and what are the perspectives for the near-term.

Roundtable II.

The importance of system management in social security

Challenges encountered in social security management and the importance of managing reform processes and initiatives.

Consider challenges encountered of social security systems, including but not limited to: the impact of technology on pension systems and payment of medical care benefits; healthcare system changes and challenges; and, good governance and its relevance to tension and healthcare systems, or the challenges of population aging and increases in life expectancy.

Roundtable III.

Some challenges on social security

In order to make progress in improving social security it requires an adjustment process, modernization initiatives or changes in its management structures and interaction with the target population. Some of these efforts are in future initiatives and the challenge of execution that test the institutional framework and the operational infrastructure.

Nations and entities seeking to achieve progress within the social security sector our undertaking reform processes, modernization initiatives or changes in their management schemes and the manner in which they interact with their respective target populations. Some of these efforts involve initiatives which remain to be executed. Therefore, it remains to be seen if the institutional frameworks, as well as the operational infrastructures, of social security systems are up to the task.

The provision of goods and services to the social security sector has always constituted a critical issue in terms of the leadership charged with management of its systems. In addition to traditional supply chains,

globalization and new supply-system strategies, increasing dependence on outsourcing or public-private ventures, have generated a permanent set of challenges and contexts for social security leadership. Additionally, phenomena such as the judicialization pharmaceuticals, as well as the issue of collusion and the dividing up of markets by suppliers, constitute serious management challenges and alter costs which impact the efficiency with which services can be delivered; and even has a significant impact upon the manner in which reform policy is structured. The following questions merit answers: What is occurring in terms of the provision of goods and services? How are goods and services being provided? What are the repercussions of this dynamic in terms of service-delivery costs and the viability of the strategies being put forth?

Presentation of the Longitudinal Social Protection Survey (LSPS): a public-policy planning tool

The survey is oriented to contribute to the presentation of the regional Project implemented by the Inter-American Development Bank (IDB) in collaboration with the Inter-American Conference on Social Security. The survey is oriented to contributing to the institutional strengthening of governments throughout the Americas in terms of the design and formulation of public policy directed at improving funding and social-protection benefits delivery.

The LSPS provides an in-depth analysis of social protection systems in terms of coverage, efficiency and sustainability. It serves as the basis for future reform initiatives, as well as the analysis and evaluation of social policy and programs. The LSPS is currently underway in the following nations: Brazil, Chile, Colombia, El Salvador, Paraguay and Uruguay.

Social Law Commission of the Americas: Revista Perfiles

During April 18-22, 1966 the XIII Session of the Inter-American Social Security Permanent Committee was held in *San José, Costa Rica*. The event marked the first time urgency that was detected in terms of creating a new entity entitled Social Law Commission. The body was designed to address the legal and socioeconomic problems of social security throughout Latin America.

The periodical entitled *Perfiles* was founded by the Social Law Commission, which published its first biannual edition in January 1996. The publication is designed to provide a forum for dialogue between the Member-Entities which comprise the CISS. Its pages provide an opportunity for individuals working within the social security sector to remain abreast of the latest regulatory changes occurring among the membership. *Perfiles* also provides information regarding knowledge and information which are of interest to the field throughout the Americas.




All individuals attending the events being held August 24-26, 2016 within the framework of the XXVIII CISS Ordinary General Assembly are asked to please take into account the following:

Mexican visa information

Information up to date as of November 9, 2012

Nationals from the following nations or regions must obtain a visa for travel to Mexico. For trips involving purely recreational, business or any non-remunerated activity within Mexico for no more than 180 days, the aforementioned is individuals must solicit a visitor's visa at a Mexican consulate; said visa in no way permits the bearer to pursue remunerated activities.

Foreign nationals possessing one of the following documents are not required to apply for a Mexican visa:

- a) Document establishing permanent residency in Canada, US, Japan, the United Kingdom or any other nation within the Schengen Area.
- b) Valid US visa.

- c) APEC Business Travel Card approved by Mexico.
- d) Certificate at correcting individual as member of flight crew on arriving aircraft.
- e) Seaman's Book, if a member of a crew on the vessel arriving to a Mexican port during an international voyage. If a crew member arrives by air in order to board a ship in a Mexican port, said individuals must also present documentation accrediting their status on the crew, embarkation details and the Mexican port from which they will set sail.
